Labor Foreman \$1.25 above highest paid laborer under his supervision
General Foreman \$2.00 above Labor Foreman

**Environmental Work: Within the Counties of Clark, Coles, Cumberland, Douglas, Edgar, Eastern Moultrie, Shelby, Macon and Western Moultrie, an additional ten (\$.10) cents per hour training contribution shall be paid by Contractors for each hour worked by Laborers that are performing asbestos abatement and removal, hazardous and toxic waste cleanup and removal and lead based paint abatement and removal on jobs identified in the bid documents as environmental projects.
